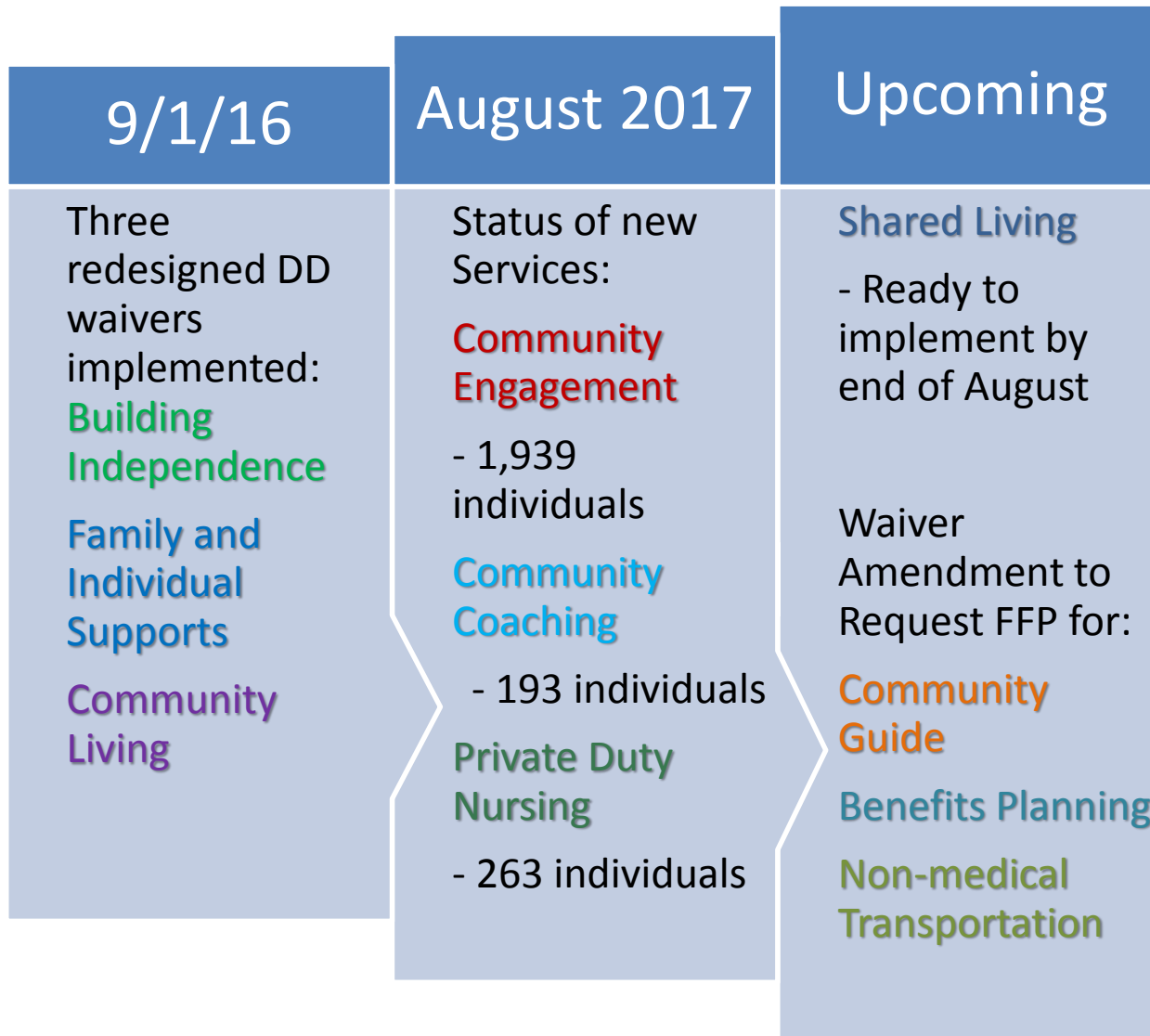

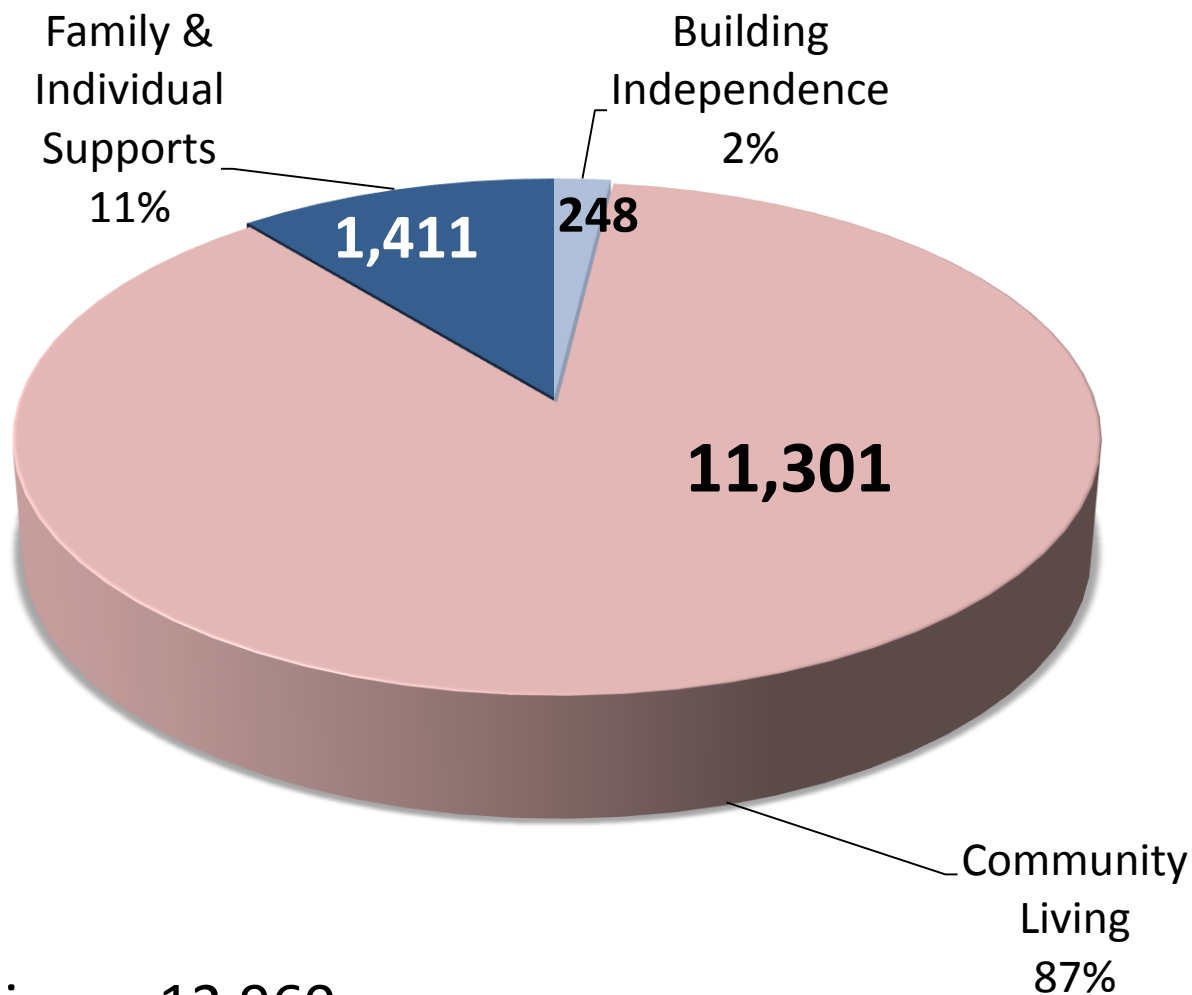

# Waiting List Update

<b>Priority I</b> Projected to need services in a year	<b>Priority II</b> Expected to need services in 1-5 years	<b>Priority III</b> Expected to need services in five years or more
<b>3,154</b> Individuals	<b>4,966</b> Individuals	<b>3,816</b> Individuals
<b>Total Waiting List = 11,936</b>		

# Building Independence Waiver and Independent Living

- 6/1/17: CMS approved different process to access:
  - This waiver targeted to those who request “a more integrated, independent living arrangement.”
  - Priority 1  2  3
- Seven new BI waiver slots assigned to individuals since 6/1/17
- Independent Living:
  - 679 people in the Settlement Agreement population living in their own rental housing in the community
  - 336 people living independently through the Housing Choice Voucher Admissions preference and the State Rental Assistance Program
    - 52 more people in process

# Reserve and Emergency Waiver Slots

## – Reserve

- To transition a DD waiver recipient whose needs have changed to another DD waiver to access necessary services
- 40 FY17 reserve slots have been distributed
- 13 individuals now waiting to move between waivers

## – Emergency

- Abuse/neglect + no other caregivers available *or* death/lack of caregiver
- 4 emergencies in the past year

# Predicted and Current Levels Distribution

Level 1	Low	7.30%	7.20%
Level 2	Minimal to moderate	37.90%	41.00%
Level 3	Low to moderate with some behavioral challenges	2.4%	4.30%
Level 4	Moderate to high	38.70%	31.00%
Level 5	High to maximum	5.30%	3.20%
Level 6	Extraordinary medical	6.90%	7.90%
Level 7	Extraordinary behavioral	1.50%	5.40%



# Supports Packages

- A mix of residential and day services equating to an overall dollar amount based on an individual's living situation and level of needed supports
- Types of living situations:

Group Home	Living with Family
Sponsored Residential	Living Independently
Supported Living	Building Independence

# Waiver Management System Updates

- WaMS is an electronic system for managing:
  - Waiting list
  - Slot assignment
  - Service authorization
  
- Future developments:
  - Including the Individual Support Plan
  - Functionality for Supports Packages

# Sponsored Residential Individuals & Providers

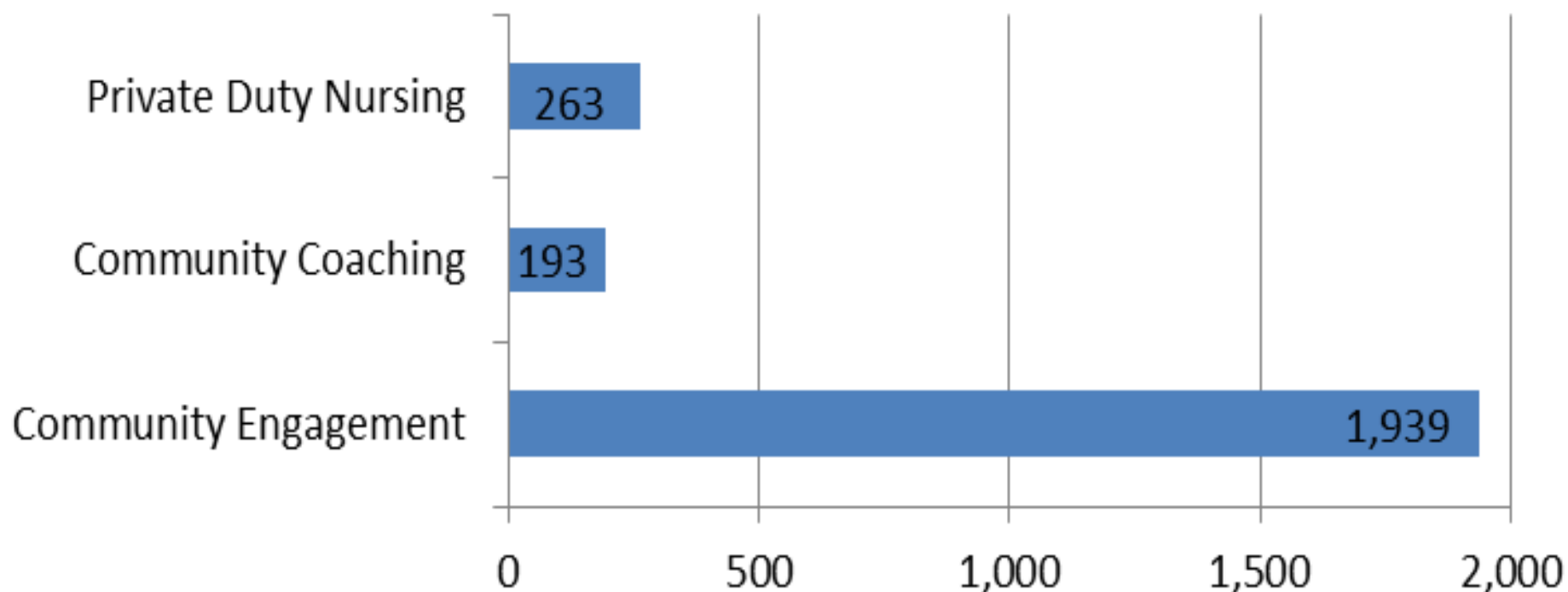
