NOTE: Project timelines vary based on the scope/complexity of the study and availability of information and data.

- Lead to objective conclusions and policy options

2021 JCHC Meeting Schedule

Goals for Executive Subcommittee

- Review legislation referred to the JCHC from 2021 Session
- Hear staff recommendations for whether the JCHC has the capacity to address the issue during 2021
- Determine if and when to address referred legislation

Interstate Medical Licensing Compact (HJ 531)

- **Summary**: Study the legal implications, and impact on availability of providers, of joining the Interstate Medical Licensing Compact
- Alignment with Strategic Priorities: Accessibility
- Workload: Medium
- Recommended Action: Staff provide a memo to the patron; no full staff study

NOTE: HJ 531 was patroned by Delegate Helmer.

Assisted Living and Auxiliary Grants (SJ 293)

- Summary: Evaluate the Auxiliary Grant program and develop a blueprint to address housing and care needs
- Alignment with Strategic Priorities: Affordability, Accessibility, Quality, Equity
- Workload: High (staff do not have capacity in 2021)
- Recommended Action: Consider as a priority study for 2022

NOTE: SJ 293 was patroned by Senator Spruill; the resolution was approved by both Chambers but the language 'requests' that JCHC conduct the study.

Universal, Single Payer Health Insurance (HB 2271)

- **Summary**: Hire a contractor to analyze the costs, benefits, and financing of a universal, single payer model in Virginia
- Alignment with Strategic Priorities: Affordability, Accessibility
- Workload: High; would require additional appropriation
- Recommended Action: Consider after completion of current Affordability study

NOTE: HB 2271 was patroned by Delegate Samirah.

Association Health Plans for Realtors (SB 1341)

- **Summary**: Would have authorized association health plans for the realtors in Virginia
- Alignment with Strategic Priorities: Affordability, Accessibility
- Workload: Low (can be incorporated into Affordability study)
- Recommended Action: Incorporate an analysis of SB 1341 into the current staff study of Affordability in the Individual Market

NOTE: SB 1341 was patroned by Senator Barker.

Summary of referred legislation and recommended action

Referred legislation	Recommended action
Interstate Medical Licensing Compact (HJ531)	No staff study; staff provide memo to patron
Assisted Living and Auxiliary Grants (SJ293)	Include as a top study priority for 2022
Universal, Single-Payer Health Care (HB2271)	Consider following the completion of affordability study
Association Health Plans for Realtors (SB1341)	Staff analyze as part of the affordability study
