## Purpose of the JCHC guides study topic selection process

"The purpose of the Commission is to study, report and make recommendations on all areas of health care provision, regulation, insurance, liability, licensing, and delivery of services."

"Commission shall endeavor to ensure that the Commonwealth as provider, financier, and regulator adopts the most cost-effective and efficacious means of delivery of health care services so that the greatest number of Virginians receive quality health care."

- Code of Virginia; § 30-168

## Strategic objectives provide framework for evaluating proposed study topics



"The Commission shall encourage the development of uniform policies and services to ensure the availability of quality, affordable and accessible health services."

- Code of Virginia; § 30-168

## Comprehensive staff study of one topic must be completed in 2025

Policy solutions to the Commonwealth's fentanyl crisis

- Mandatory study required by HJ 41 (Srinivasan), approved by the General Assembly during the 2024 Session
- Study resolution directs the JCHC to complete work by November 1, 2025

- School-based initiatives to improve digital literacy and awareness of the impact of social media on youth mental health

## Medicaid eligibility criteria and options to eliminate Medicaid benefits cliffs

#### Study objectives:

- Describe program-specific eligibility requirements across eligibility categories
- Determine the extent to which individuals move between eligibility categories
- Describe the events that trigger transitions between eligibility categories
- Identify strategies to reduce the negative impact of events that trigger transition between eligibility categories on access to services

## Strategies to address transportationrelated barriers to health care

#### Study objectives:

- Determine the type and prevalence of transportation-related barriers that patients experience in Virginia, and which populations are most affected
- Describe the effectiveness of interventions that address transportationrelated barriers
- Identify strategies to improve or expand programs in Virginia to address transportation-related barriers to accessing care

## Strategies to address pharmacy deserts

#### Study objectives:

- Determine how community access to pharmacies has changed in Virginia over time, and what populations have been most impacted
- Identify the factors that contribute to pharmacy deserts
- Describe effective strategies implemented in other states to improve access to pharmacy services
- Identify strategies Virginia could implement to address pharmacy deserts

## Services for individuals with traumatic brain injury

- Describe services currently available for individuals with TBI in Virginia and identify the number of individuals served by those services
- Describe challenges, barriers, or gaps in Virginia's continuum of services for individuals with TBI
- Identify strategies Virginia could implement to address gaps in the continuum of services for individuals with TBI

## Strategies to improve health literacy

- Identify the factors that contribute to low health literacy and the populations in Virginia most at risk for low health literacy
- Describe interventions to improve health literacy at the individual- and community-level

## Access to Medicaid personal care services

- Describe the personal care services workforce in Virginia and how the availability of personal care attendants has changed over time
- Identify factors contributing to shortages in personal care services for Medicaid members in Virginia
- Determine policy strategies Virginia could implement to improve access to personal care services for Medicaid members

## Options for design of a food and nutrition Medicaid benefit

- Identify options to implement a Medicaid food and nutrition benefit to reduce nutrition-related chronic disease and food insecurity
- Determine how other states have designed similar benefits
- Define the costs, benefits, and return on investment of Medicaid food and nutrition benefits
- Identify options for design a Medicaid food and nutrition benefit to reduce nutrition-related chronic disease and food insecurity in Virginia
